III. Chief of Staff Updates

- A. <u>Cabinet Climate Analysis</u>
 - 1. Connor: Jessica made the entire survey, so s/o to her for that. Because this was a short survey, I want to focus on the main topics so we can build off of our strengths and weaknesses.
 - Weaknesses: a lot of people's confidence is shaky (don't feel as if they are doing well in their positions, especially compared to other secretaries.) There are some positions that are more public, so it seems more flashy, but just because it's more public doesn't mean that you aren't doing a great job.

- 3. Jess: that note of comparison is important to bring up. We are all high-achieving, and that means we tend to compare ourselves and our accomplishments to others. Just a reminder that you are all doing great work and compare it only to yourself rather than others! Y'all are great!
- 4. Connor: Collaboration is a weakness and a strength. It was polarizing. A lot of 4/5s and a lot of 1/2s. We should talk collectively about what we want to do. Same thing with cohesiveness as a team.
- 5. Connor: A lot of awesome strengths. Excitement to get to work this semester was awesome (y'all are go-getters). People felt like their goals are being met or close to being met. That's all about the hard work we do. Support from leadership was also a strength...you all gave us a lot of feedback for both Cab/Senate leadership.
- 6. Jess: Cabinet leadership is not a hierarchical term, but rather how can we be a resource.
- 7. Connor: we should do more check-ins outside of Zoom (like our in-person meeting Uptown)
- 8. Jess: about strengths being utilized...responses were all over the place, and I'm personally very passionate about. If you are in a situation where you feel that your strengths are not being utilized, I'd love to chat with you to ensure that we are increasing productivity.
- 9. Connor: Scott and I were talking about the workload, the work that we have faced during our terms has been four to five times as much as past Cabinets. Stress is reasonable, but your mental health should be prioritized. You need to be mentally healthy in order to be the best in these positions. If you need a break, please let me know -- they are completely valid.
- 10. Connor: big egos in the room → you are taking the 15 top student-leaders in the room and putting them together. There are going to be big egos, but we don't want egos to get in the way of productivity, and we don't want people feeling inferior. I wanted to have a conversation about that here because it is harder to have a conversation.
- 11. Brandon: I had concerns about big egos. We have some of the brightest people / most hard working, but my issue is that egos interfere with ability to collaborate. Last year, people were actively coming to me for collaboration/advice. This year, I'm not seeing that at all. The ego thing comes off disrespectful around D&I things. People assume they can do things without me, which defeats the point of collaboration.
 - a) Connor: could we walk through a process guide?

- b) Brandon: if I was doing a voter suppression thing, why wouldn't I go to Ben for this? Things like that.
- 12. Connor: Let's make a guide for how we want to reach out to people for collaboration. What do people think?
 - a) Ruku: Coming on to Cabinet late in the game, I was confused about who to loop in and how many people to loop in, especially with C/NC. The same with administrative committees, I feel in over my head because I'm the only student and would love to have more people helping.
 - b) Connor: Who here has felt as if collaboration went really well, and who can walk us through the process?
 - (1) Ruku: C/NC went well. As stressful as it was, everyone was super onboard. Dan and I are on APC at 8:30 in the morning and were on the same page. We were able to talk about that in the Cabinet slack as well, which helped.
 - (2) Connor: should we use slack for groups for collaboration? Having people reach out via slack?
 - (3) Jess: asking "Who is interested?" I feel guilty reaching out because others may have a lot on their plate and adding one more thing may deter collaboration. Asking in the chat for who is interested feels less like you are putting a burden on someone else.
 - (4) Brandon: I've had to combat that with Jannie because I don't want to stress her out more than she is, but I don't think it's ever a bad thing to put something out there. It's fine to go to someone with an initiative and if they have too much on their plate, having them tell you.
 - (5) Connor: I want to set this as a tone. You should not feel bad for saying "no" if you have too much on your plate.
 - c) Trey: I think it's a double standard on both parts...if you see something that you feel as if you should be collaborating on, you should reach out to set up a time to chat, especially since it's probably not intentional and just slips through the crack.
 - Connor: Yes, but we still need to loop them in. The responsibility shouldn't fall on the person who's left out, it should be the responsibility of the person leading the initiative.

- (2) Brandon: it's not my responsibility to track everything and other people's minutes. We don't have a collaborative mindset.
- (3) Jannie: my idea of how we start to have a collaborative mindset is trying to figure out how we can make our initiatives collaborative. We need to have that active mindset. Almost like self-reflecting on where projects intersect. Like the Mental Health Forum, intersections with Safety, Comms, D&I.
- d) Scott: I think that what you are doing is perfect. I haven't seen anyone trying to be spiteful, I just think you all get so busy and forget to reach out. Part of the collaborative process is having these open conversations.
- e) Harper: I struggle with reaching out to people because I'm terrible with starting conversations. I feel like breaking down any walls we have with each other is key, especially when fostering collaboration.
 - (1) Connor: how can we break those walls down?
 - (2) Harper: I get intimidated by the work that other people are doing (they are doing so much), so I don't want to start that conversation. I'm not sure what work we can do to break down these walls.
 - (3) Connor: would a template for collaboration help?(a) Harper: Yes.
 - (4) Jannie: During 1-on-1s with me, you all said we don't have a lot of connection. Something that may help is doing like 1-on-1s with each other. We really never have those times to get to know each other. Like schedule little dates with each other.
- 13. Ben: being mindful of the way we talk about other people's projects, even if it's not in ASG.
- B. Comments on SBP and SBVP Elections
 - 1. Connor: Elections are coming up and ASG leads that. I don't want this topic to be taboo once election season starts. We need to leave elections outside of this room, which may be difficult to do. Elections are fun, and stressful. If you are running/part of a campaign, please keep that bias outside of these meetings.

- A. Dan: As you all know, Effie worked on an initiative last year that has now come to a new state. After conversations with administrators, I can announce that ASG is partnering with the Armstrong Student Center Board to add 12 menstrual product dispensers in the student center. In the long term ASC will be funding it but ASG will be funding it for the launch. This Tuesday, there will be an amendment to the IOB to add this to the budget. I would like to show an overwhelming support for this and would like you to show your support by being present at that meeting. A few of you will be writing letters of approval for this and I would like to invite more of you to write as well. The goal is to get this to Senate as soon as possible. By tomorrow, Reena will get the information to be sent out to senators and it will be added to the Slack, as well.
- B. Jessica: for a bit more context, this has been in the works since last march. Then the global pandemic hit and it was put on hold; however, after looking at the budget the AMC has decided to pursue it further. It has been a hasty process, because before we actually went through with the conversation, I wanted to loop in others to collaborate. AMC board members, members of Spectrum, and ASG all had a voice in this initiative. I just wanted to clarify why this is an amendment rather than on the original IOB of this semester.
- C. Scott: Dan, is the conversation going to be about the money or how the money is being spent.
- D. Dan: A little bit of both. I think the main concern will be why we are paying for it and not Armstrong. We have a lot of money left over and this is something we can afford. Otherwise that money will go left unspent and unutilized. As DAC said - and I agree - I cannot see a better way to use student fee dollars.
- E. Scott: I think too that Katy and I agree part of this is that Effie is the person who pushed this and it would have happened a year ago if the pandemic didn;t happen. This is a huge opportunity to set a standard for other buildings at Miami. As Dan said, we were ready to start this right before the pandemic happened, so it should happen now.
- F. Dan: Again, if anyone wants to share their thoughts or concerns, please Slack them to me. I'm super busy, but I will try my best to see it.
- G. Megan: I just want to say that if this does get passed, I would want to put out a story to show this great achievement.

- A. Sen. Giang and Sen. Stephens
 - Sen. Stephens: I just have some questions and a concern to get answered. The concern is regarding groups who sing and their inability to gather to practice, whereas other groups of artists (such



as dancers) are able to practice still. This is difficult because the singing groups are still being asked to perform, which obviously makes it difficult for these groups to work. I understand that COVID passed quicker through singing, but we do wear masks. Just wanted to get some perspective on this one.

- Sec. Waugh: I have a contact with J.S. Bragg in Student Activities.
 I'll bring this up with him and see what we can do.

We already have brought many concerns to this committee from the beginning of this semester that have been cleared up very quickly because I am able to contact the people in charge of them quickly and easily.
- 8. Sen. Stephens: Just so I'm understanding, which students sit on the committee?



- Sec. Pal: A representative from Lockheed Martin in the CEC, a representative from the Regional campuses, Sec. Pal, and Sen. Capriolo
- 10. Sec. Pal/Sen. Maldonado: We have multiple subcommittees that handle smaller minutia of COVID-19 that kinda meet together into the bigger committees of the ASG COVID-19 Ad Hoc and the Safe Return to Campus committees.
- 11. Sen. Stephens: Final question I have stems to the general idea of communication. How can we best improve communication: where are we, and how can we improve it?

 - Senator Stack Came back to campus really excited to work on some initiatives. Specifically is very excited to have more productive discussions regarding SafeRide.
 - 2. Senator Scott Today in onboarding, some new senators were bouncing ideas off one another. She is looking to compile an app to put sorts of resources, especially looking into updating the Miami app.
 - 3. Senator Wu Wants to continue looking into the STI work started last semester. Looking for more accessible funding for that. Wants to revamp the university's mental health resources, and AWARENESS. Outside of safety, he also wants to look into student debt initiatives and gender equality in the engineering school (78-22).
 - 4. Senator Rionda Interested in working on mask adherence, wants to see how enforcement can work.
 - a) Senator Wu Where do we draw the line with that? Bikes to campus.
 - 5. Senator Stack Looking into increased communication with ASG and OPD to improve mask enforcement.

- B. Checking in about initiatives from last semester:
 - Senator Wu Didn't get too far on it last semester, but essentially looking at how to make STI testing more accessible on campus. STI testing (he thinks) costs around \$30-\$300 depending on insurance. Reached out to Planned Parenthood, but due to their current situation, they aren't really able to offer cheaper options. The university has health and wellness grants that students can use to cover these sorts of things.
 - a) Senator Bracely Explore at-home STI test kits, that could be provided at campus markets.
 - 2. Senator Stack Was looped into conversation with Secretary Bosworth and some admin. There have been technical issues with the app (BCRTA) and this has limited access. Might change every year, but has a foundation. Also forces ASG to actually read it. Also want to bring up about the Miami Code of Conduct, which there is a clause against alcohol and drug use. If this were to pass, it would be an Oversight-able document. It's up for interpretation by whoever.
 - Elghazawi: I don't think anyone would actually do it.
 - Chenkus: I do think it's something for concern, and someone could use it for petty reasons.
 - Villanueva: I do think it's something that could be used for petty reasons. That's where when we look at these things we have to have confidence in future Committees. We have to have some level of confidence in them.
 - Chenkus: It just feels like why would we put something in there that we don't expect to use.



- Villanueva: Do you want to take away the part about the Code of Conduct? In the Constitution it's been interpreted that way for a while, and part of it is also leading by example. We wanted to put it in there explicitly. Technically there is nothing in the bylaws that say ASG members have to promote safe COVID protocols for example. There are things in the Code of Conduct that aren't in our own bylaws that should be encompassed. Oversight is built to have flexibility in terms of "smaller" violations and also to encompass restorative practices.
- Sassan: I think we are obligated to include it as a student organization of Miami University. If we don't include it it sets a precedent that we are somehow above the Code of Conduct. We can't predict what will happen in the future but you can only hope that sensible people will be part of this body, but I think it's important to include.
- Kravitz: I totally get the University's policy, I don't think ASG should be another avenue to enforce that. It is a foundational document, but ASG as an institution helps change the environment on campus. We're a changing body.
- Villanueva: It's a fair concern. It's why the Senate Leadership and Cabinet decided to make this a Senate approval document like the Standing Rules. If it passes as is there's nothing to say that the Senate next year can't change it next year either. It changes with the times.
- Elghazawi: I think we need to have confidence in future bodies and that the body is liberal enough to not legislate on these types of things.
- Villanueva: If someone violates the Code of Conduct and they are disciplined, but it doesn't violate something in our bylaws, they could probably not face repercussions in the future in ASG. I think it's important to look at it that way. It's been petty before and it can be in the future, and that will happen no matter what we do with this. I want to make sure this is as best as it can be before it is brought to the Senate.
- Chenkus: I don't like how easily this could be used against people for political reasons or just disagreements in general. I'm not sure what the solution would be. I think we could use certain parts of the Code of Conduct and not all.
- Kravitz: I'm leaning one way or the other. I definitely think it can be abused, but this changes from year to year and something that's worth bringing to the Senate to have a full discussion.
- Elghazawi: I say the Senate should have a say on it but keep it in for now.
- Committee vote
 - 6-0-0 in favor of bringing to the Senate.

To the Representatives of Luxembourgish Students at Miami,

After deliberation, the Judicial Council of the Associated Student Government has decided to uphold the sanctions laid upon your organization by the Committee for Student Organization Funding and Audit, in violation of Associated Student Government Standing Rules Sec. 15.4.

The basis of our decision was found in accordance with the Associated Student Government Bylaw 711.D., which states that the committee shall consider "intent, severity, magnitude, and negligence." We found that your organization was directly negligent in your actions, as you failed to contact the Committee on Student Organization for Funding and Audit in order to figure out a solution for your unspent funds. Furthermore, the organization was given five months to spend the approved funds and apply for a sweep exemption, which it had prior notification of from the Committee. The officers of the organization stated during the hearing that they did not get back by the deadline for sweep exemptions due to their own negligence.

Although we recognize that the Associated Student Government's website did not reflect the current bylaw change at the time your appeal was submitted, it is the decision of the Council that this discrepancy weighs little on the negligence and lack of intent displayed by your organization and its officers. However, we do apologize for the bylaws not being present as updated, and will work diligently with the Parliamentarian of the Student Senate and the Secretary for Communications and Media Relations to update the website at the earliest opportunity.

II. Announcement from the Chair

- A. Omar Elghazawi, Off-Campus Senator
 - Senator Elghazawi: today we will be hearing an appeal from the Luxembourgish students at Miami for restrictions set upon them by the funding and audit committee. We will begin with opening statements--each side will have 5 minutes. Each member of the council will have 10 minutes to ask both sides questions. CLosing remarks will be 5 minutes for each party.

III. Opening Statements

- A. Luxembourgish Students at Miami
 - Jake: We are appealing the harsh 25% penalty to our funding for next semester due to misused funds. ASG has thousands of unallocated dollars that should be allocated to... ASG bylaws 711d state that the F&A committee must consider severity and unprecedence of these situations. This 25% penalty is harsh, and the changes due to the pandemic were not made publicly available--these updates bylaws are not made publicly available on ASG's website. How does ASG promote fair and equal access to

funding? We ask to rule in our favor and to eliminate this penalty or minimize it to the lowest penalty possible

- 2. Jake yields all time left back to the chair--1 minute
- B. Committee on Student Organization Funding and Audit
 - 1. Secretary Bosworth yields all time remaining back to the chair

IV. Questioning from the Council

- A. Jannie Kamara, Student Body President
 - 1. LuxSM: were there any individuals you could have passed off this responsibility to?
 - 2. Jake: only Claudia and I received the email
 - 3. Claudia: we're barely making the minimum of members. Our other executive member was just a freshman. Between me being gone and Jake being alone, no one else could take that responsibility

B. Jessica von Zastrow, Student Body Vice President

- 1. Funding & audit secretaries, why are these penalties in place if student organizations are not able to hit the benchmark for spending?
- 2. Secretary Bosworth: it comes down to fiscal responsibility. This penalty discourages organizations from over requesting funds. This is a rule that predates us as chairs. Mr. Kravitz took on this responsibility when he requested these funds on August 25th.
- 3. Funding & audit, this is a tier 1 organization. Does funding and audit have different rules for tier 1 organizations?
- 4. Secretary Bosworth: no, there is no difference in rules and standards for all student organizations. The only difference is the amount of funds they may request
- 5. LuxSM, did you take the Canvas course to understand the funding guidelines?
- 6. Jake: yes, and I attended an optional SEAL workshop
- 7. Claudia: I did as well
- 8. LuxSM: why did you not apply for a sweep exemption?

- 9. Jake: the deadline slipped away. I am slightly confused by the argument of the sweep back exemption being flexibility--I don't think flexibility should end at a certain date
- C. Trey Petrella, Secretary for On-Campus Affairs
 - Funding & audit, is there any rule in place that if an organization wouldn't be able to use all of their funds by the deadline, could they ask for an extension?
 - 2. Secretary Waugh: there is a sweep back exemption that students can apply for. This application was open until January 8th, and student organizations were able to submit applications based on unique circumstances that we would make a ruling on. We did not receive a sweep exemption from this organization nor did they reach out to us via email. In an email to organization back in August, ASG funding acknowledged this semester would require flexibility and allowed organizations to contact us to adjust any potential remaining funds
 - 3. LuxSM: was there any part from the treasurer or the president to clarify the sweep exemption process?
 - 4. Jake: it wasn't a lack of clarity, but I did not manage to get back by the deadline
 - 5. Claudia: Personally, I was having issues with flying home from at the time. This is also our fault, and we could have reached out to ASG, but we do not want to have this penalty for this next semester
 - 6. Jake: these circumstances only add to the factors that should be considered with the bylaw
 - 7. Funding and audit, when did LuxSM apply for this funding?
 - 8. Secretary Bosworth: August 25th
 - 9. LuxSM, is there a reason you guys applied for this funding but did not spend the minimum amount?
 - 10. Jake: those reasons are outlined in an appendix
- D. Emily McClary, Secretary for Off-Campus Affairs

- 1. Funding and audit, how has funding and audit given flexibility to students based on the pandemic?
- Secretary Waugh: again, I contacted all organizations to ensure they knew of our flexibility. Both chairs determined to lower the percentage of required spending because of the pandemic as well. We have made beyond reasonable accommodations for all student organizations
- 3. LuxSM: you said you believe the changes to the bylaws have been made ex-post facto--why?
- 4. Jake: we requested this funding way in the past before this bylaw change was made. There is nothing inherently in the ASG bylaws against ex post facto, but it also was not made publicly available
- E. Omar Elghazawi, *Off-Campus Senator*
 - 1. Jake, you are a voting member of ASG, correct?
 - 2. Jake: yes
 - 3. Jake, you voted yes to the bylaw changes discussed, correct?
 - 4. Jake: yes. At the end of the day, we need to consider what is publicly available. When preparing for the appeal, I had to contact the Speaker of the Senate. What was available on the website at the time was out of date
- F. Cameron Tiefenthaler, College of Arts and Sciences (Soft) Senator
 - 1. Funding & audit, what in this appeal stuck out to you in terms of severity? What made this a severe case that required sanctions?
 - 2. Secretary Bosworth: this is a mandatory sanction that is put in place with the ASG bylaws in mind. In this situation, this was an objective decision that complies with the standing rules and the bylaws. The bylaws do not restrict us from imposing mandatory sanctions. This applies to all organizations in this situation

- 1. Funding and audit has 14 minutes
- 2. Funding & audit: you have heard excuses and admission. At no point has the organization denied violating the standing rules. We have a long standing policy that we will not get involved with intra-organization issues. There was no reason not have used the funds that were requested for Jackbox games and an extension pack. This is not a harsh penalty; it has been in place for a long time, long before our time at Miami. We believe we have been fair, equitable, and objective. Severity, negligence, magnitude, and intent were all considered. There was no lack of communication. The organization could have reached out to us, and they admitted they did not reach out to us. A surplus does not matter when examining the fiscal responsibility of organizations; if they request too much, they should still receive a penalty. Changes were made publicly available. They are always available to students who request it. We were extremely transparent, including in emails. The organization had every guideline sent out by student activities. The organization had increased access to the documents and the committee. Changes were made following the rule of ASG. It is not the responsibility of the funding & audit committee to update the website, but the Parliamentarian. Jake admitted he went to the workshop that we discussed these policies at. Letting a deadline slip away is not a valid excuse; organizations were reminded before the deadline. We were flexible, but there also has to be a date that this expires. We cannot reach out to every organization, organizations have to reach out to us. As chairs, we have made increased efforts this year to contact presidents and treasurers every time a change was made. We have been proactive and reminded organizations to reach out. Information was also sent out to the advisor and vice president. The date of the request was not ex post facto. On the funding request, Mr. Kravitz acknowledged

this. This should not be appealed to student senate; these bylaws have been appealed. This is not a body of law, so we do not have to adhere to legalities, even though ex post facto does not apply. Mr. Kravitz had access to the bylaw change. We are not under obligation to receive senate approval. This is a way to get out of something that falls on the treasurer and the president's lack of communication. We have made every good faith gesture possible to help student organizations during this time. We have to be fair to all organizations, which means we need to penalize all organizations in the same sentiment. We request this council to reject this appeal and to keep this penalty, not reduce it because that sets a bad precedent.

- B. Luxembourgish Students at Miami
 - 1. LuxSM has 10 minutes
 - 2. We have an understanding that we spend money for events during the event. We do not admit to the violation but do not contest it. This penalty is harsh to us because we don't have as much money, so 25% matters to us. Denying \$50 is a lot of money for someone working in a low wage area. The committee could have offered flexibility when we initially appealed to the committee. Traditions are not bylaws. Transferring in parliamentarian is fair to be an issue, but should further prove that flexibility is needed. We did not have increased access. My capacity as a student senator should not affect the justice here. The sweep back exemption does not change the fact the committee should consider extenuating circumstances. We are confused how auditing was done and do not believe it was random. Interpreting this situation as objective, if the committee does not believe that the language is in there, it should be in there. The question is how does ASG promote fair and equal access to funding? We would like to ask the council to rule in our favor and eliminate or reduce the penalty imposed.

VII. Adjournment

Dear Judicial Council,

Pursuant to Funding and Audit Standing Rule Section 14.3, this document is an appeal to the Judicial Council with attached grievances. Respondent asks for the Judicial Council to refer to both the attached original appeal (Appendix A) and subsequent denial of relief from the chairs (Appendix B) before consulting this document, for proper context.

Upon denying relief to Luxembourgish Students at Miami, the committee chairs cited Funding and Audit Standing Rule Section 15.4 numerous times. In the view of the respondent, the chairs entirely relied on Funding and Audit Standing Rule Section 15.4 for its rationale in denying relief. The chairs themselves state that their rationale is founded "mostly on the fact that the sanction in this matter is the standardized and mandatory penalty as outlined in the Standing Rules". However, the rationale applied by the committee holds no standing as committee standing rules do not supersede the bylaws of the Associated Student Government. In fact, Funding and Audit Standing Rule Section 1.2 states "These standing funding rules, upon ratification by the Student Senate, are subsidiary only to the ASG Student Senate at large, the ASG constitution, and the ASG Bylaws".

In light of the lack of any consideration of ASG Bylaw 711.D on faulty premises, the respondent asks the Judicial Council to perform its own consideration of ASG Bylaw 711.D on these grounds alone. Therefore, on the same merits outlined in Appendix A, the respondent requests the elimination of the imposed funding reduction in its entirety with a warning from the Judicial Council.

If and only if the aforementioned grounds and requested relief are not satisfactory to the Judicial Council, the respondent requests that the Judicial Council consider the following grievances and possible relief. Respondent recognizes that the Judicial Council is under no obligation to limit the grounds of its rulings but may choose to do so.

ASG Bylaw 711.A.5 requires that the Committee on Student Organization Funding and Audit, "Submit any student organization sanctions to the Student Senate for a vote of approval". Additionally, ASG Bylaw 711.D. requires "The sanction to be imposed shall be decided by the Student". The Committee on Student Organization Funding and Audit has not submitted the respondents alleged violations to the Student Senate. Regardless of any alleged unknown and unwritten past precedent, bylaws take supremacy.

Furthermore, numerous parts of ASG Bylaw 711.A. require that violations are of restrictions set forth in "Section 716". Section 716 appears to not exist in materials available to the public online. The nonexistence of section 716 calls into the question the ability of the Student Senate and certainly the Committee on Student Organization Funding and Audit to impose sanctions.

Lastly, the respondent objects to the grounds of the audit of the respondent. ASG Bylaw 711.A.1-3 state various grounds for which to audit the respondent. The Committee on Student Organization Funding and Audit cited "random audits" as it's grounds for the audit when unilaterally imposing the sanction (Appendix C). Thus concerning ASG Bylaw 711.A.2., the

respondent alleges that the audit was not random but automated based on financial data available to the Committee on Student Organization Funding and Audit. While reasonable to audit based on the aforementioned information, the audit would then indeed not be random. Furthermore, if all student organizations are audited in this manner, the process is still not random. The letter of the bylaw in question should be amended if this is the case for the practice to continue.

The respondent realizes that changes have recently been made to the bylaws concerning funding requirements. The respondent believes these changes were made ex post facto to the date funding was requested and approved. Common law and understanding dictates that changes must not be retroactive. Furthermore, the lack of availability of the updated bylaws to the public online at this very moment, the only truly publicly accessible platform during a pandemic, constitutes an undue burden to the respondent and the general public. The aforementioned burden is itself a violation of ASG Bylaw 206.C.1. and should not penalize the respondent. Concerns about the lack of availability were raised in Appendix A and are apparent.

In light of the lack of certainty of the ability for the Committee on Student Organization Funding and Audit to have imposed sanctions on the respondent, the respondent requests the elimination of the imposed funding reduction in its entirety.

If and only if the requested relief in the totality of the appeal are not satisfactory to the Judicial Council, the respondent requests that the Judicial Council consider a reduced penalty to the respondent's funding.

OPPOSITION TO APPEAL AND MOTION TO DENY

RESPONDENT'S RESPONSE AND OPPOSITION TO PETITIONER'S APPEAL TO THE JUDICIAL COUNCIL

Respondent Committee on Student Organization Funding and Audit ("the committee" or "F&A"), by and through undersigned chairs Ben Waugh, Secretary of Finance, and Dan Bosworth, Secretary of the Treasury ("chairs" or "co-chairs"), hereby move this Council to deny the above-captioned appeal and uphold the findings and sanctioning in this matter. The facts in this case are outlined below.

I. PARTIES

 Petitioner¹ Luxembourgish Students at Miami is at all times relevant herein a Registered Student Organization ("RSO") at Miami University.

¹ Petitioners improperly and erroneously refer to themselves in their appeal letter to this council as "Respondents." For this appeal, Respondent refers to the Funding and Audit Committee, while the Petitioners are the organization.

- 2. Petitioner Representative Claudia Zaunz is at all times relevant herein the president of Luxembourgish Students at Miami.
- Petitioner Representative Jake Kravitz is at all times relevant herein the treasurer of Luxembourgish Students at Miami.
- Respondent Funding & Audit Committee is at all times relevant herein a Senate Committee under the Associated Student Government ("ASG").
- Respondent Representative Ben Waugh is at all times relevant herein the Secretary of Finance of the Associated Student Government and the Chair of the Committee on Student Organization Funding and Audit.
- Respondent Representative Dan Bosworth is at all times relevant herein the Secretary of the Treasury of the Associated Student Government and the Chair of the Committee on Student Organization Funding and Audit.

II. JURISDICTION

1. This council has jurisdiction over this matter pursuant to ASG Bylaw 302.E.

III. NATURE OF RESPONSE / FACTS

- This response arises from a violation of Funding and Audit Standing Rules regarding the minimum percentage of awarded funds that must be spent in a given semester by student organizations.
- Petitioners were a Registered Student Organization during the fall semester of the 2020-2021 academic year.
- Petitioners were classified as a "Tier 1" organization within the Red Brick Rewards system, co-managed by ASG and the Office of Student Activities.

- 4. As a Tier 1 organization, Petitioners were able to request a maximum of \$1,500 in the fall semester from ASG via the Funding and Audit Committee, among other rewards as outlined in the rewards system.
- On Tuesday, August 25, 2020, at 11:32 AM EDT, Petitioner's treasurer Jacob Kravitz submitted a funding application for the Cycle 1, Opportunity 1 funding hearing. See Ex. A.
- 6. Mr. Kravitz, in his official capacity, completed the application, including acknowledging that the organization must spend 75% of approved funds within the semester, and that failure to spend 75% of funds would result in a 25% penalty of funds for the following semester. *Id.*
- 7. As the Petitioner's request was under \$300, the committee reviewed and decided on the application through the (amended²) pre-approval process, allowing for the determination of the application to be made absent of an organization representative.
- 8. Petitioners requested funds for an online game night, described as "[a] get together playing onlien (sic) games with Luxembourgish students at Miami. We hope to get to know members better as well as having fun! The event will build community and enrich the Luxembourgish experince/ties (sic) on campus." See Ex. B.

² The amendment in this case refers to the reduction of the pre-approval amount from \$500 to \$300 as a result of the COVID-19 pandemic. In this matter, the organization would have been subject to the pre-approval protocols either way, and any argument against the pre-approval should be rendered moot by this council.

- Petitioner's request consisted of two items: (1) Jackbox Party Quintpack in the amount of \$98.75, and (2) Keep Talking and Nobody Explodes in the amount of \$14.99. The vendor for both items was listed as Steam. *Id.*
- 10. The event was listed to be held on September 23, 2020. The event was submitted on the HUB and was listed as "Approved," thus complying with the requirements of the committee regarding event submissions on the HUB. *See Ex. C.*
- 11. The committee unanimously voted to approve the funding request for Petitioners in the total amount of \$113.74. *See Exs. B and D*.
- 12. Petitioners did not request funding at the Cycle 1, Opportunity 2 hearing.
- 13. The total approved funds for the fall semester for Petitioners was \$113.74.
- 14. On December 8, 2020, Respondent's Chair, Ben Waugh, sent an email to all RSO presidents, vice presidents, treasurers, advisers, and entity accounts detailing the sweep exemption policy. Included in this email was information announcing that the committee chairs had decided to lower the spending threshold from 75% to 60% in light of the ongoing COVID-19 pandemic. In this email, the deadline for sweep exemption applications was listed as Friday, January 8, 2021. See Ex. E.
- 15. At the aforementioned deadline, Petitioners did not file a request for sweep exemption.
- 16. On January 9, 2021, the Committee on Student Organization Funding and Audit issued a Notice of ASG Funding Audit to Petitioners. *See Compl. Ex. C.*
- 17. In this notice, Petitioners were found in violation of F&A Standing Rule 15.4, which states, "Organizations must spend 75% of all funds approved in a given cycle. Failure to spend at least 75% of funds within the semester in which funds

are approved will result in a 25% reduction of approved funds in the next funding cycle. Organizations approved for a sweep exemption will not receive this penalty³." *Id*.

- 18. The evidence provided to the committee stemmed from a Financial Account Report generated from the HUB on January 8 at approximately 11:50 PM EST. See Ex. F.
- 19. On the aforementioned report, the balance remaining in Petitioner's ASG Funding account of SD9076 was \$113.74, representing all approved funds for the fall semester. Based on this information, Petitioners spent zero percent (0%) of approved funds for the fall semester. As 0% is less than the 60% requirement, the Petitioners failed the audit. *Id*.
- 20. Petitioners were assessed a mandatory penalty of 25% on approved funds for the spring semester of the 2020-2021 academic year. *See Compl. Ex. C.*
- 21. Petitioners were advised of their appeal rights as found in Article XIV of the Funding and Audit Standing Rules. *Id.*
- 22. On January 23, 2021, Petitioner's treasurer, Jake Kravitz, submitted an appeal to the chairs of the committee on the grounds that the committee failed to consider the sanctioning guidelines as outlined in ASG Bylaw 711.D. *See Compl. Ex. A.*
- 23. Petitioners claims in their appeal to the chairs that (1) there was a lack of intent to not spend allocated funds due to communication issues with the organization's adviser in relation to the event funding requested, (2) the severity and magnitude of the infraction was minute due to the "comparatively small amount" of unspent funds in comparison to "other organizations,", and (3) that the treasurer's (Mr.

Kravitz's) inexperience as a treasurer of an organization demonstrates a lack of negligence on the part of the organization. *Id*.

- 24. Petitioners closed their appeal requesting an elimination of the 25% penalty and a warning from the committee. Petitioners request, in the alternative, a reduced penalty. *Id*.
- 25. Petitioners at no point in their appeal dispute the findings in this matter, nor do they object to the fact they did not spend their approved funds.
- 26. On January 27, the chairs of the committee sent the Petitioners an ASG Funding & Audit Appeal Determination, stating that (1) the appeal ground lacked merit,
 (2) the findings in the case were upheld, and (3) the desired appeal outcomes were denied. *See Compl. Ex. B.*
- 27. The chairs, in their letter, explained that the determination made by the committee carries a mandatory sanction as stated in F&A Standing Rule 15.4, which incorporates the four factors of intent, severity, magnitude, and negligence found in ASG Bylaw 711.D. *Id.*
- 28. The chairs further explained that the COVID-19 pandemic was not a valid grounds for appeal, as multiple good-faith gestures were made by the committee to provide additional flexibility, including reducing the required spending threshold to 60%. *Id.*
- 29. The chairs upheld the sanctioning decision made by the committee. Id.
- 30. Petitioners were advised of their right to appeal to the Judicial Council in the determination notice. *Id.*

- 31. Petitioner's treasurer, Jake Kravitz, contact the ASG Funding email within an hour of sending the determination, requesting the information for submitting an appeal to the council, stating, in part, that "A certain decision to appeal in either case of which I am a respondent in is currently in flux."⁴ *See Ex. G.*
- 32. On Wednesday, February 10, 2021, Petitioners, through treasurer Jake Kravitz, submitted the above-captioned appeal to the Judicial Council. *See Ex. H.*

IV. RESPONDENT'S ANSWER TO APPEAL

- Respondent admits that Petitioners have the right to appeal under F&A Standing Rule 14.3.
- Respondent agrees that this council shall refer to previously sent notices in their decision-making. Respondent also submits other evidentiary documentation for this case to the council, as noted herein.
- 3. Respondent admits that Standing Rule 15.4 was referred to several times in the appeal determination.
- Respondent denies that the chairs "entirely relied on [F&A] Standing Rule [...]
 15.4" in the determination of the appeal.
- 5. Respondent admits that, in the appeal, the chairs stated that their determination is founded "mostly on the fact that the sanction in this matter is the standardized and mandatory penalty as outlined in the Standing Rules."
- 6. Respondent denies that the rationale cited in the determination "holds no standing." Petitioners, in their appeal, cite the parliamentary hierarchy of

⁴ Mr. Kravitz is the treasurer of another organization that was penalized and subsequently appealed to the chairs for a violation of S.R. 15.4. The decision in that case was identical to the case herein, as the appeal was almost exactly the same as the appeal submitted to the chairs for Petitioners in this case. For reasons unknown to the Respondent, that organization did not submit a Judicial Council appeal within the mandated time frame.

standing rules in comparison to bylaws. However, the Petitioners do not address the fact that ASG Bylaw 711.D. states:

"[u]pon determination that a violation has occurred, the Committee shall render a sanction unto the student organization. The Committee shall consider intent, severity, magnitude, and negligence in their decision. The sanction to be imposed shall be decided by a majority vote of the Committee on Student Organization Funding and Audit. Any student organization found to have committed a violation may, however, obtain review of such sanction(s) through the appeals process outlined in the Committee for Student Organization Funding and Audit Standing Rules, which will include a review by the Judicial Council."

- 7. Referring to IV.¶6, ASG Bylaw 711.D was invoked in this case, as the mandatory sanctioning, which has been a precedent of the committee preceding the current chairs tenure, took into account the four aforementioned factors.
- 8. Respondent admits to the context of Standing Rule 1.2.
- Respondent denies that there were "faulty premises" in relation to any lack of consideration to ASG Bylaw 711.D.
- 10. Respondent calls on the council to uphold the sanctioning, despite Petitioners' request to remove the penalty.
- 11. Prior to continuing this answer, Respondent notes that, in paragraphs 5, 6, and 7, Petitioners point to outdated and incorrect ASG Bylaws related to student organization funding and audit, as funding-related bylaws were updated on November 10, 2020 through SB202106, and immediately effective. *See Ex. I.*

- 12. Respondent calls on this council to dismiss the claim regarding sanctioning approval through Student Senate, as such mechanism no longer exists in the ASG Bylaws, as Bylaw 711.A.5 no longer exists. *Id.*
- 13. Respondent is under no obligation to report to or receive approval from Student Senate regarding any sanctions rendered by the committee. *Id*.
- 14. Respondent agrees the bylaws rank higher than standing rules, but disagrees with the context invoked in Petitioners' appeal, since, as was previously mentioned, the mandatory penalty already considers the factors in Bylaw 711.D and is well within the limits outlined in the ASG Bylaws⁵.
- 15. Respondent denies for lack of knowledge the statements regarding an alleged ASG Bylaw 716.
- 16. Objection. Respondent objects to Petitioners calling into question the ability of Associated Student Government to impose sanctions based on a former bylaw, and formally requests that the comment made in paragraph 6, sentence 3 of the appeal be stricken and called out of order. The basis for such objection is supported by the current ASG Bylaws, which do not contain any mention of a Section 716. Notwithstanding the corrections made, the absence of a bylaw should not be a meritorious ground for subjectively stating that ASG, whether it be through Student Senate or the Funding and Audit Committee, lacks the ability to impose sanctions on an organization in violation of funding regulations, or any regulations for that matter. Such comment lacks professionalism or decorum, even if submitted in writing and not stated verbally in a parliamentary-based

⁵ Notwithstanding that the ASG Bylaws often refer to the Standing Rules for clarification and policy on numerous occasions.

proceeding, and is not becoming of a representative of a registered student organization at Miami University.

- 17. Respondent denies the objection to the audit.
- Respondent admits that ASG Bylaw 711.A⁶ dictates the various powers assigned to the committee regarding auditing.
- 19. Respondent admits that the Notice of ASG Funding Audit mentions random audits, but denies the allegations that such an audit was not random, or that this audit was meant to be random.
- 20. Respondent notes that Petitioners fail to identify any evidence that proves such an audit was not random. Petitioners point only to the fact that they "[allege] that the audit was not random[,] but [rather] automated based on financial data available to the [committee]. While reasonable to audit based on the aforementioned information, the audit would then indeed not be random." Petitioners fail to identify in any aspect how the committee did not randomize the process or randomly select organizations. There is no evidence to show the committee failed to conduct a random audit.
- 21. Notwithstanding the previous paragraph, it is duly within ASG Funding's powers to perform audits when a violation is known to have occurred.
- 22. Respondent denies that **all** [emphasis added] student organizations were audited in this manner, as not all student organizations received a Notice of ASG Funding Audit.

- 23. Respondent does not understand Petitioners' statement regarding "the letter of the bylaw."
- 24. Respondent adamantly disagrees with Petitioners' overall allegations regarding bylaw changes.
- 25. Respondent admits that changes were made to the ASG Bylaws regarding Funding and Audit. Respondent submits to this council SB202106, passed in Student Senate on November 10, 2020, for review. *See Ex. I.*
- 26. Respondent disagrees with the statement regarding changes being made "ex post facto to the date funding was requested and approved." The Committee on Student Organization Funding and Audit is obligated to follow the current bylaws and standing rules as passed by the respective bodies within Associated Student Government. Neither the committee, nor ASG, is under any obligation to grandfather organizations into certain rules.
- 27. Respondent notes that the Associated Student Government, and subsequently the committee, is not a legal body, therefore, common law standards do not apply. Notwithstanding the previous statement, common law dictates that changes are made immediately. There is not a provision in any common law element that requires an entity to wait to enforce a law.⁷
- 28. Subsequently, Respondent denies that any enforcement of such changes were done retroactively. The date of the infraction⁸ was well after the revisions were made⁹. The policies put into place regarding the 75% spending rule were made

⁷ For example, the City of Oxford's ordinance limiting mass gatherings to no more than ten (10) people applies wholly to all individuals gathering within Oxford's city limits; there is no exception if an event was planned prior to the ordinance being signed or if someone did not live in Oxford prior to the ordinance taking effect -- all community members must immediately follow said ordinance. apparent to Petitioners at the time of their submission of a funding application, as acknowledged by Mr. Kravitz.

- 29. Moreover, the committee made additional relaxations of policy prior to the date of the violation, in order to make the spending threshold more easily attainable.
- 30. Respondent admits that the bylaws on the ASG website are not up-to-date, specifically pointing to a sudden transition in parliamentarians in recent months.
- 31. Respondent denies that such absence of updated ASG Bylaws presents "an undue burden" to Petitioners. In fact, Petitioners' treasurer, Jake Kravitz, is a member and voting senator of ASG's Student Senate. Mr. Kravitz voted "aye" on SB202106, modifying the ASG Bylaws in relation to student organization funding and audit. As such, Mr. Kravitz was in possession, from November 9 onward, of the updated bylaws. Thus, for this organization, there was no "undue burden."
- 32. Respondent denies that the bylaws and/or changes to bylaws were not made public to the general student body, and further refutes that such aspect has anything to do with the current pandemic. ASG documents are considered public record under Ohio Revised Code, and as such, any individual can request updated records at any time.
- 33. Furthermore, Mr. Kravitz, operating in his official capacity as the treasurer for two organizations, including Petitioners, contacted the ASG Funding & Audit Committee for that exact purpose on January 17, 2021, specifically asking for "a copy of F&A Standing Rules as they were on January 9, 2021." Chair Dan Bosworth complied with the request, pointing Mr. Kravitz to the ASG HUB page,

where the standing rules were up-to-date and effective at the time referenced. *See Ex. J.*

- 34. Respondent also notes that SB202106 is posted as public record on ASG's website under "Legislation."¹⁰
- 35. Notwithstanding any of the previous paragraphs in relation to the lack of updated bylaws on the website, such publicity of the bylaws did not disadvantage Petitioners, or any organization for that matter, in this case.
- 36. Petitioners were aware of the 75% rule, as previously mentioned, and were further made aware of the reduction to 60% in the December 8 email from Chair Ben Waugh.
- 37. Respondent denies for a lack of knowledge any violation of ASG Bylaw 206.C.1, as that specific bylaw falls outside the realm of this committee or the chairs. Furthermore, any argument that this "penalizes" Petitioners is rendered as moot, as it has clearly been established that the organization had the means to access updated regulations at any given time. In addition, the Secretary for Communications and Media Relations is not at fault, as maintenance of the ASG Bylaws are the responsibility of the Parliamentarian and the Administrative Committee¹¹.
- 38. Respondents formally request that all sanctions and findings in this matter are upheld, contrary to the request of Petitioners.

39. Respondents formally request that the sanction in this matter not be reduced to ensure equity across all student organizations penalized for this violation, consistent with F&A Standing Rule 15.4.

V. ADDITIONAL COMMENTS FROM RESPONDENTS

- 1. Respondents lodge several complaints and reaffirm several arguments with this process:
 - Petitioners never contacted the committee regarding the inability to spend funds until after they were penalized.
 - 2. Petitioners agreed to such a penalty when submitting their funding application. See. Ex. A.
 - Petitioners had access to the Bylaws by several means, including (1) Mr. Kravitz's position as a Student Senator, (2) contacting the committee, (3) contacting the Speaker of Student Senate and/or Parliamentarian, (4) referring to the website, (5) accessing the ASG Shared Drive.
- In addition, Respondents feel it necessary to address the comments made in Appendix D by Petitioners' treasurer Jake Kravitz:
 - Respondent finds the comments made in said appendix offensive, insensitive, unprofessional, and disrespectful to not only the committee/chairs of Funding and Audit, but ASG as a whole.
 - 2. The comments made in Appendix D were unnecessary for consideration in this matter, as the comments are outside of the scope of this council.

- 3. At no point did respondent, or any other entity, allude that Petitioners would not receive a "fair shake" merely due to the status of Mr. Kravitz being in ASG.
- 4. Respondent requests that the comments regarding the "nature of ASG" be disregarded and blatantly ignored in making this determination; Respondents believe that such a statement is abhorrent in nature coming from any individual and has nothing to do with this appeal.
- 5. Respondent would like to especially comments on Mr. Kravitz's statement regarding the appeal determination. Mr. Kravitz points to feeling targeted as his name was "mentioned three times." For context, Mr. Kravitz is referring to the following statement:

"On January 23, 2021, Luxembourgish Students at Miami Treasurer **Jake Kravitz** submitted an appeal request to the Chairs of this committee, stating his belief that the audit decision rendered by the Committee on Student Organization Funding and Audit ("the committee" or "F&A") was misguided. **Mr. Kravitz** appealed based on the factors stated in ASG's Bylaws surrounding sanctioning, specifically referring to ASG Bylaw 711.D.

On January 26, 2021, Secretary of Finance Ben Waugh and Secretary of the Treasury Dan Bosworth ("chairs" or "co-chairs") met in executive session to review the appeal submitted by **Mr. Kravitz**. [emphasis added for counting purposes]"

6. Considering the above statement, the wording used is the same wording that is used for all appeal determinations. Mr. Kravitz's name was used as he was the individual who submitted the appeal to the chairs. At all other points after the first paragraph, plus one sentence, Mr. Kravitz's name was not mentioned once, rather referring to the organization.

- 7. Respondent never assumed that the appeal was solely Mr. Kravitz's.
- 8. Respondent is in no way making "things personal." To be frank with this council, Respondents are frustrated that such a comment was made, as it insinuates that such proceeding is indeed personal for Petitioners' treasurer. It is important to note that in no way does Respondent believe this is a personal matter.
- 9. Respondent appreciates Mr. Kravitz's growth throughout this process.

VI. PRAYER FOR DETERMINATION

- 1. Respondents repeat and reallege each and every allegation and statement set forth above as if fully rewritten herein.
- 2. WHEREFORE, for the foregoing reasons, Respondents respectfully request that this Honorable Council:
 - 1. Uphold the finding of "Evidence Found" in relation to Petitioners' violation of Funding and Audit Standing Rule 15.4;
 - Uphold the sanction of a 25% penalty on all approved funding awarded from the period running from January 1, 2021 through June 30, 2021, covering the entirety of the spring semester of the 2020-2021 academic year;
 - 3. Dismiss the above-captioned appeal with prejudice for the reasons set forth in this brief;
 - 4. Strike objected to material as set forth in this brief from the official record of these proceedings.
