  - i. Secretary Waugh: Secretary Bosworth and I created this training to help senators and student orgs better understand how the funding process works
  - ii. Secretary Bosworth: this is pretty self-explanatory, it's to help you better understand what we do in ASG. You need to move through this sequentially. Please fill out the feedback form so we can tweak it before we roll it out to student orgs next semester. Fill it out by October 30th
  - iii. Speaker Pro Tempore Villanueva: you will receive 3 points if you don't do it. This is an important part of what senate does, so please don't complete it just to finish it

  - a. Secretary Bosworth: I am here for any questions or concerns. I let you know that Secretary Pal did not request any funds, so the budget has been adjusted for that
  - b. Senator Kravitz: I'm a little concerned about the high cost of gift cards for On-Campus
  - c. Senator Kravitz yields to Secretary Petrella
  - d. Secretary Petrella: I am very big on constituent outreach. To cater towards first year students, we will be touring high first year populated and holding events to engage them with winners. We'll be awarding gift cards to local businesses. Secretary Bosworth has my outline
  - e. Secretary Petrella yields to Secretary Bosworth
  - f. Secretary Bosworth: I support Secretary Petrella, and I think this amount is fair. We need to engage students
  - g. Secretary Bosworth yields back to Secretary Petrella
  - h. Secretary Petrella: this is also a much less amount than usual
  - i. Secretary Petrella yields back to Senator Kravitz:
  - j. Senator Kravitz: these are coming from our agency funds, which is self-generated. There's a limited amount of agency funds. This is 22% of what we have in agency funds. I think this amount should be halved.
  - k. Senator Doepke: this is less than we would be spending normally. I do have an issue with the money coming out of our agency fund, but we can do more fundraising. I think this is a great way to engage first years
    - Senator Capriolo: how often are these funds used?
  - l. Senator Capriolo yields to Secretary Bosworth
  - m. Secretary Bosworth: we rarely use agency funds. That being said, I'm thinking about ways to fundraise, and cabinet members have already been working on it. Ethically, we will not use student fee dollars for gifts.
  - n. Senator Chenkus: how much agency funds do we have?
  - o. Secretary Bosworth: \$1,566

- p. Senator Chenkus: for the water bottle pass out money that still hasn't been paid out, would we use agency funds?
- q. Secretary Bosworth: personally, I am not aware about water bottle pass outs. Secretary Finfrock, could you speak on this?
- r. Secretary Finfrock: I have been made aware of that concern
- s. Secretary Bosworth: I am still not concerned about the proportion of agency funds
- t. Senator Sassan: this is a lower cost than usual and i think it's a great way to bring people together
- u. Senator Waugh: I do not see an issue with the use of agency funds. We haven't used them since 2016
- v. Chief of Staff Moreton: the amount of money you invest into these engagement efforts directly correlates with the success
- w. Senator Wu: the agency funds are to be used for unusual situations, and we are in an unusual situation.

## A. Funding Hearing Layout (rooms/virtual vs. in-person)

- 1. Sec. Waugh: we are going to be hybrid and giving orgs the option of how they want to do their hearings. We won't know the popularity of each until next Friday when forms are due. In-person first, then virtual. Ben will be in 1066, Dan in 1086. Chair + 7 members + 2 org reps.
- 2. Planning: Nikhil and Vasudha are remote for the semester. Max and Jasmine elected to be remote for the hearing.

## B. Preapproval time for Sunday, October 4th

- 1. Sec. Waugh: meeting canceled next Friday and we will move the meeting to Sunday 10/4. 5-6pm looks like the time with the least amount of conflicts.
- 2. Sen. Gates: I can move that around
- 3. Sec. Waugh: don't feel obligated to you won't get a point since it is a special meeting and we will have well above quorum

## C. Terms for at-large members

1. Sec. Waugh: at-large members were either given an academic or calendar year term. Seniors have the option to change their term from calendar to academic if they want to stay on. Please let us know if that is something you would be interested in within the next week. We will ask if any sophomore/junior at-large member can move to the calendar year term, and will receive preference for a calendar year term.

## D. Future meeting structures

1. Sec. Waugh: I'd love to have a hybrid meeting format now that we are back in person. Other Cabinet members are either going fully



- in-person or hybrid. We can't do it fully in-person because of our size, but what are people's thoughts?
- 2. Sec. Bosworth: My idea is that we have five or six people in the office for the meeting, along with Ben and I, and the rest of the committee can be on Zoom and we can broadcast it on the TV in the office. We can then rotate who is in-person every week, so you would have one in-person meeting, two virtual, and the cycle continues. Ideally, this will just be for the fall, but we may continue this into the spring depending on what happens.
- 3. At-large member Morris: I think virtual would be easier for me as a new member, especially since it would be hard to have breakout groups between in-person and virtual
- 4. At-large member Jensen: I think the exact opposite; I learned way more being in-person than I would ever learn being online. We can easily do breakout groups by just splitting up the virtual people into two and having the in-person group as one.
- 5. At-large member Hillyer: I thought the same thing as Harrison for still being able to break out groups in person and virtual; I'd be chill with staying virtual all semester, though
- 6. At-large member Deer: I disagree with Harrison it's gonna be hard being 6 feet away from people, because that's how I learned best last year
- 7. At-large member Lutz: I don't see a difference in efficiency between in-person and virtual



- 8. At-large member Hillyer: I do most of my learning during in-person hearings, it was definitely harder to learn for virtual hearings
- 9. At-large member Beyer: I'm not sure the difference, but I would be fine either way
- 10. Sec. Waugh: let's trial run the hybrid, but not for pre-approvals.

  Our first hybrid meeting will be on October 9th. If you want to come, you can.
- 11. Sen. Patel: I think trying is a good idea doesn't matter for me though
- 12. At-large member Jensen: it's easy to participate in-person

  - 1. Small: the first one was in 2018 in response to incidents of bias happening on campus, put on by previous secretary Courtney Rose. Last year was a response to how Miami was treating its diverse students. With BLM and the election happening I think this year would also be a major one.



- 2. Wu: the targeting of Asian students and international students due to COVID should be addressed. There's been various incidents of hate speech and such on campus.
- 3. Small: I agree, I think since a lot of us aren't Asian students it's not something we notice.

  - d) Small: if we do something with DM then we shouldn't use stories already posted on there. I think potentially we can ask them to help create a space to share those stories. I think if they don't respond we can have a conversation about that, could also be something we focus on in the panels.
