

- VII. Report A: Trey Petrella, Farmer School of Business Academic Senator & Ben Waugh, Farmer School of Business Academic Senator
 - a. Sen. Waugh: we just wanted to remind you to remind your constituents to apply to get their fee waived if they need to stay the Friday night before winter break. They need to apply by noon on the Wednesday prior
 - b. Sen. Petrella: if a resident forgets to sign up, they technically have until Thursday, but that is only for last minute requests. Another update, this will be extended to summer break as well
 - c. Secretary Fraley: if an extenuating circumstance and you don't know until the last minute, you can still email Brian about the fee
 - d. Sen. Barr: to clarify, this is for the students who need to stay for just Friday night, correct?
 - e. Sen. Waugh: yes
 - f. Sen. Barr: is there a way we can
 - g. Sen. Waugh: they don't want to really advertise this because they don't want people to stay just to stay
 - h. Sen. Conner: international students will pay to stay in a room. Often they will split the cost
 - i. Sen. Bosworth: for Thanksgiving, would it be Tuesday or Wednesday night?
 - j. Sen. petrella: it's not for thanksgiving
 - k. Sen. Sarfino: if we can't advertise this, how will people know?

 - m. Sen. Arbetter: what is the deadline to communicate if the student needs the fee waived, just to clarify?

 - s. Secretary Fraley: RAs also send out a google spreadsheet to all residents about whether or not
 - t. Sen. Barr:
 - u. Sen. Waugh: on the form, you have to provide reason. Brian said he will approve almost anything
 - v. Sen. Conner: what kind of pushback did you get from RDs?
 - w. Sen. Petrella: they thought this would make all RAs and RDs stay a day late, which is not true
- VIII. Report B: Shelby Frye, Off-Campus District 7 Senator & Ben Waugh, Farmer School of Business Academic Senator
 - a. Sen. Waugh: swipe donating tabling will happen next week, and we need everyone to take part in it to help make it happen. We need to get as many swipes as possible to show administrators that we need this. If you have not fulfilled your tabling, this is a great way to do that
 - b. Sen. Waugh demonstrates how to collect the swipe

- c. Sen. Frye: someone will use their laptop to activate the swipe collection. If the student does not have their ID, they can just type in their unique ID

- X. New Business Item A: SB192006 "A Bill to Require Bystander Intervention Training"
 - a. Sen. Frye: this would essentially add, much like the multicultural events, a requirement for bystander intervention training.
 - b. Sen. Bosworth: when will this take effect?
 - c. Sen. Frye: next year, it will go into full effect. For next semester, I will work with people on how to approach it
 - d. Sen. Hankins: is it necessary for the Secretary of Safety to compile a list?

- XI. New Business Item B: SR192007 "A Resolution to Modify Operating Hours at Dividends"
 - a. Sen. Bosworth: Dividends is the ala carte location in Farmer. The hours are not very representative of the students' needs. There are a lot of students in the building from 5 to 6 PM Monday through Thursday, when Dividends is closed. We have pushed back the opening time to 8 Am and then pushed back the operating hours to 6 PM.

- Additionally, we limited Friday hours from closing at 4 PM to 1:15 PM. We conducted a survey, and 86% of students said they would utilize it.
- b. Sen. Finfrock did you talk to anyone who works at Dividends?
- c. Sen. Bosworth: a few of the respondents were Dividends workers, and the only feedback we got was that they are a little understaffed, which is a campus wide problem
- d. Sen. Finfrock: would this affect their schedule in a negative way?
- e. Sen. Bosworth: Dividends might have to implement a second shift.
- f. Sen. Petrella: we are not adding to the number of hours of workers at Dividends. When we spoke to Dividends, it was made clear this would not happen
- g. Sen. Hankins: so no matter how many transactions are happening at Dividends, the same amount of workers are working?
- h. Sen. Bosworth: correct
- i. Sen. Parker: what is the nearest market?
- j. Sen. Bosworth: Garden Market and Dorsey Market are close by, but do not offer the same services Dividends does
- k. Sen. Finfrock motions to end questioning and move to debate
- l. Motion passes
- m. Sen. Finfrock: I am still concerned about making workers stay until 6 PM. This would take up a large part of their night
- n. Parliamentarian Radilla: I would personally rather hear from the workers
- o. Sen. Hudak: as a student worker, it's really not that big of a deal since we can choose our own hours
- p. Sen. Martini: if you want to work then, then you should be able to
- q. Sen. Lutz: I'm a business student, and basically all my classes are in Farmer. I think this just makes sense
- r. Sen. Singleton: if I were a worker, I would want to be made aware of the extension to 6 PM
- s. Sen. Waugh: when we meet with Dividends, we will make sure all communication is clear that we do not want to put stress on the worker. The union contract is in place
- t. Sen. Bosworth: we will also be requesting a trial run before doing anything permanent
- u. Sen. Elghazawi: as a student, they schedule around your classes and around your schedule. If this is a concern for students, students can just let their
- v. Sen. Finfrock: why did you not do a trial run before?
- w. Sen. Bosworth: this is the first time that any actual change is made to the hours, and they asked for student support before going anything
- x. Sen. Petrella: Brent Mason said he would not consider this if he did not have student support
- y. Sen. Sarkisian motions to end debate and call to question

- XII. New Business Item C: SR192008 "A Resolution to Reform Title IX Policies"
 - a. Sen. Arbetter: we believe this is a first step towards helping prevent SIV. This would create mandatory suspension with recommendation for expulsion for anyone found guilty of sexual assault. As of right now, it is on a case by case basis which has resulted in a lot
 - b. Sen. Elghazawi: are there any administrators who are against this?

- c. Sen. Arbetter: A few have voiced opposition in the past. They have since then agreed to work with us and are willing to work with us
- d. Sen. Petrella: the reason why we felt that we should bring this to senate because I believe that there are times when we have to go against administration. Sexual assault is a felony, and we should have minimums for something that is a felony
- e. Sen. Elghazawi: what if the suspension is not what the victim wants?
- f. Sen. Arbetter: we have talked to people who have said that from a victim's standpoint, it is so hard for students to see their perpetrator around campus
- g. Sen. Petrella: this would also only occur if a victim chooses to pursue the Title IX investigation
- h. Sen. Frye: why should it only apply A1?
- i. Sen. Petrella: this is just a start for any SIV prevention efforts, and this is a good start towards working with administration
- j. Sen. Arbetter: Title IX is also so broad that we wanted to focus on the extremes when meeting
- k. Sen. Devedjian: was the general counsel consulted?
- l. Sen. Petrella: we only met with Dean Moore because they would be the one implementing this
- m. Speaker Siegel: this is also just in order of how the Office of Community Standards carries their investigations
- n. Parliamentarian Radilla: do you think this will differ from when it comes to people of color and targeting them particularly?
- o. Sen. Arbetter: we are using this as a way to hold students accountable for their actions. I am not clear where the concerns regarding people of color come from
- p. Sen. Arbetter: on a case by case basis, I would say that that is more biased against minorities because not everyone is held to the same standards
- q. Sen. Waugh: because administration does not agree with this, how would you expect this legislation passing to change anything?
- r. Sen. Arbetter: This is just a starting point. We plan to continue to work on this regardless of what is the outcome of debate
- s. Maddie from Women Helping Women: the language in your bill does not match Miami's language. We do not use words such as "guilty" and "perpetrator". I also have an issue with 1A being separated from 1B because it might make those who report 1B feel invalidated. I am concerned that mandatory minimums would not have a good impact on people wanting to report. They usually don't want to destroy the perpetrator's life
- t. Sen. Murphy: do you have any plan for if this will deter reporting?
- u. Sen. Arbetter: if they choose to go through this, regardless they will know that they have this option
- v. Sen. Murphy: don't you feel this prioritizes the punishment for the respondent rather than the victim's wants?
- w. Sen. Arbetter: we need to hold the respondents accountable, and this was a starting point
- x. Sen. Hankins: you said you were in support of considering other options, would you support tabling this bill?
- y. Sen. Petrella: I will stand by what we wrote
- z. Sen. Arbetter: we have been working on this since March. We felt it was time to bring this to the floor and have this conversation about it.

- aa. Sen. Barr: does this take into account the appeals process?
- bb. Sen. Arbetter: if either party does not agree with the outcome of the outcome, either party can appeal that. That is ongoing, this would occur at the end
- cc. Sen. Tyree: given that Title IX is a federal law, do you know if any other universities have a policy like this?
- dd. Sen. Arbetter: no
- ee. Sen. Petrella: we are also the only university who has minimum ramifications for alcohol
- ff. Sen. Hankins: is the only way to hold people accountable for sexual assault mandatory minimums?
- gg. Sen. Arbetter: we feel this is the best option moving forward to get the conversation started
- hh. Sen. Stephens: how do you believe this would be productive to the safety of our students?
- ii. Sen. Arbetter: passing this bill would promote safety because we are standing up for the survivor and ensuring the respondent is not on campus if the survivor is not okay with being on them
- ij. Sen. Stephens yielding to Maddie: how do you view the current reporting process?
- kk. Maddie: it's supposed to be an educational process versus a harsh sentencing process.
- ll. Sen. Barr yielding to Maddie: what pool is drawn from to create the panels that review these cases?
- mm. Maddie: it's on a volunteer basis. It can be university staff and faculty nn. Sen. Murphy: why is a mandatory minimum better than a case by case basis which
- can be tailored to the specific wants of a survivor?
- oo. Sen. Arbetter: this holds everyone to the same standards and holds accountability
- pp. Parliamentarian Radilla moves to end questioning and call to debate
- qq. Motion passes
- rr. Sen. Stephens: as a member of the Miami community, I believe in this legislation. If this is a felony, we need to hold it to that standard
- ss. Sen. Elghazawi reading for Sen. Moleski: a one semester suspension is a far outcry for an actual felony. All this does is set a minimum for sexual assault sanctions.
- tt. Sen. ELghazawi reading for an anonymous Senator: Miami should be unique and put this in place. I am disappointed in senate.
- uu. Sen. Doepke: so many students on campus have a general consensus that Miami doesn't care about survivors. We have a duty to make sure students are held accountable. I want to reiterate that rape is a felony. On campus, a majority of perpetrators are white, straight men. Universities have historically just given out slaps on the wrist.
- vv. Parliamentarian Radilla: I think this would be a deterrent to those who might want to report
- ww. Sen. Barr: by instituting the mandatory minimum, we lose the freedom of a judicial process
- xx. Sen. Coiner: case by case is the status quo, and our status quo on campus is a prevalance of sexual assault on campus. I think a mandatory minimum of one semester compared to what the victim goes through is a slap on the wrist. The idea that SIV is some mistake and an opportunity for growth is abhorrent. SIV is not a

- mistake. Miami cannot allow the victims to return to the same campus as their assailant and be forced to .

 - 3. Sen. Waugh: 1A and 1B are extremely similar, so if we are going to debate whether or not mandatory minimum is required for one or the other, it should be for both
 - 4. Sen. Barr: this amendment is a necessary addition should the original proposal be passed
 - 5. Sen. Stephens: I am in support of this amendment
 - 6. Sen. Petrella: I am in support, but I am just worried that it is just too much too fast
 - 7. Secretary Koenig: queer sex does not always include penetration, and that is where 1B would come in
 - 8. Sen. Elghazawi: when the authors spoke to administration, they weren't in favor of this anyways, so I am in support of it
 - 9. Sen. Hess motions to split the question
 - 10. Motion does not pass
 - 11. Sen. Doepke: we should keep 1B in here because queer sex does not necessarily mean penetration. It is important to be inclusive. We are already going against administration. These are ____

- aaa.Sen. Elghazawi: given the amendment, this resolution is more thought out and better. It's concerning we are spending so much time debating this. We need to show the student body that we care about things like this
- bbb. Sen. Finfrock: I'm done with this being the normal on the campus. We cannot allow this
- ccc.Sen. Bosworth: if we don't pass this, we are doing a disservice to so many people. This is an extra step to this process.
- ddd. Sen. Frye: the idea behind a mandatory minimum allows for level ramifications for all those

- eee. Secretary Koenig: the SIV prevention coalition created last year was overwhelmingly in favor of mandatory minimums. Since we might have to compromise with administration, this is a good place to start from. Suspension is already the mandatory minimum of alcohol here
- fff. Sen. Murphy: Maddie brought up a concern of this deterring survivors from reporting. We need to find a way to hold accountability, but I'm not sure this is the best way.
- ggg. Sen. Barr: we need to look at the other reasons why there are not more ramifications. This is reactionary.
- hhh. Sen. Hankins: there is no evidence to support that mandatory minimums This takes away some of the power the survivor has in this position. I think these people know what they're talking about
- iii. Parliamentarian Radilla: advocating for mandatory minimums is not the right thing to do. I think that this would make the status quo worse. Something has to be done, but I don't think this is it
- jjj. Sen. McClary: I support this bill
- kkk. Sen. Doepke: as it is right now, the panel does not have to necessarily take into account what survivors have to say. This happens after a survivor chooses to go through with the investigation. When someone is found guilty through the proceedings, this is a matter of public safety. This is removing an eminent threat from campus. There are mandatory minimums for many crimes except for sexual assault.
- Ill. Sen. Arbetter: Miami is always talking about how "We'll do something" for survivors, but I don't see them doing anything. This is starting a conversation between student body and administrators. There were a lot of opportunities for you to talk to us about this bill and legislation, and it is frustrating that it wasn't until it came to the floor that you had this issue
- mmm. Sen. Elghazawi: the university has failed survivors and will continue to do so if we don't do something. There's no guarantee that if we pass this administration,. I've never been as ashamed to be a senator as I am right now
- nnn. Sen. Finfrock: this is not reactionary. If you don't think this is a solution, then give us a solution
- ooo. Sen. Barr: we do not want to disempower the survivors of these terrible crimes. We should be protecting them and protecting their choice
- ppp. Sen. Coiner: We are talking about survivors. We have heard from two of these survivors and their support for it. This is the correct response. Survivors have the right to see the respondents to be properly punished
- qqq. Sen. Petrella: the time is now. This has gone on long enough at this university. We are not taking the process away from the victim
- rrr. Maddie: I am in support of the amendments. I am not opposed to minimum sanctions. If that waiver is an option, I would be much more comfortable with this.
- sss. Sen. Devedjian: no matter what happens here tonight, having this conversation is important.




