- IV. Special Business of the Day Item A: Representatives from Aramark
 - a. Scott Weir: We are both from Aramark. Amanda is going to be coming to campus as the Director of Operations. She will be bringing a wealth of experience. I'm going to be the Aramark lead here on campus. We wanted to give you a brief explanation and leave our email addresses with you. Please email one of us as you hear things, we want to fill the void with information. If something is unknown, you're going to fill it with your worst imagined thoughts. Essentially, Aramark's a multinational food service management company worth \$16 billion. We help our clients efficiently manage a top flight dining program for the benefit of the students. We talk a lot in our company about the fact that we're not in the curing cancer business, but we like to think that if we're doing our job right, we can be the highlight of students' days. If we can be the one part of the day that isn't stressful, we've done our part to help the leaders of tomorrow. If you do dine at the dining halls, we will have surveys going out next week about your dining experience. If you're going to improve, you have to reach out and ask the people for it. We're super excited to be here, and I see a lot of parallels from where I came from. This is without a doubt the most beautiful campus I've ever seen.
 - b. Senator DeVictor: A lot of the dining issues have had to do with staffing. How do you plan to address that?
 - c. Scott Weir: We have to provide competitive compensation, and we are going to do that. We're going to be around a starting wage of \$15. We also found out that it would take 4-6 weeks to get from the interview to being able to be hired. Our hiring cycle is about 3-4 days, shortening the process. There are many members of the community that used to work for Miami that no longer work for it, and we value the employee experience immensely. There are also some things around what needs to be open and what needs to be on the menu. We also want to contract local restaurants to have space in Armstrong.
 - d. Senator Hughes: There is an initiative that would instill a \$15 minimum wage for students, how would that impact Aramark's operations?
 - e. Scott Weir: I think you're going to have less of a challenge with dining because our model is predicated on the rate. Working in dining is a much

more action-oriented job and they should be the highest paying student jobs on campus.

- f. Senator Gay: What are some of the sustainability efforts you are all pursuing?
- g. Scott Weir: During my vacation, I sent an email to Rupke asking about composting. I've started reaching out to former partners in composting to start operations in the Cincinnati area. We composted everything back where I'm from, and we have a heavy emphasis on sustainability. Right now we offer compostable to-go containers with no means of composting. Part of it is understanding where should we place money in sustainability issues that students care about.
- h. Senator Gay: What are you doing to bring new items to dining halls?
- i. Scott Weir: A large part of our proposal was to give each dining hall its each personality. We want Western to be a farm-to-fork vibe with local vendors on Western, Martin centers around performance dining, Garden will be "plant forward", Maple is supposed to be a "restauranty" feel. From now, the week of May 8th our regional culinary director and executive chef will be sitting down with each dining hall. We want the GM and the chef to have ownership of the menu. A lot of the folks there now feel like they're being dictated to rather than making it their own. We're going to try to create feedback loops with students. The student dining customer experience needs to be a two-way street. My ideal state is where you all will say "this isn't good."
- j. Amanda Casey: We also have a survey coming that students will always have access and it involves immediate feedback.
- k. Senator Grabow: Is most of the funding for the plans coming from dining dollars or from an external contract?
- I. Scott Weir: There is some money between us going towards facility enhancements, but this number is not huge. A lot of the renovation work has already been completed. Part of us doing food service management are things around opportunities to reduce waste. The last thing comes from growth. If you felt like you were gonna eat the meals, you could buy them for cheaper. Part of it is growing through the incremental costs.
- m. Senator Grabow: Is this going to be a process through time to help efficiency?
- Scott Weir: Generally, I think asking for a heads up is a good preventative measure. It's a matter of finding the times to complete side work. Understanding the ebbs and flows of the business is essential to preventing buildups.

- IX. New Business Item A: Secretary for Governmental Affairs Election
 - a. Cameron Tiefenthaler
 - i. Tiefenthaler: I am running to be GR secretary. I am a second-year double major in political science and business analyst. I've spent a term and a half within ASG and have served on GR before. I have worked as a Wilks fellow for civic engagement and have worked on a presidential campaign. I have worked with many student leaders to create this platform. Collaboration of working with other organizations, inclusion of international students, and enthusiasm for voting and civic engagement are my main pillars. I want to collaborate more with the office of ASPIRE. I also want to work more with students to advocate for the things they're passionate about. I want to include all students in GRN activities and advocacy. I want to provide resources to students studying abroad during elections.
 - ii. Secretary Tyree: Is there anything else you'd like to share with Senate?
 - iii. Tiefenthaler: I want to expand the focus of GR to work on DEI projects to allow students to create their own definition of civic engagement. I have lots of knowledge about civic engagement on Miami's campus and would love to advocate for Miami students.
 - iv. Senator Hughes: A lot of GR has been collecting ASG's input on statehouse bills. What is your approach to this?
 - v. Tiefenthaler: I spoke with Randi Thomas about this. I want the position to be about more than just acting as a liaison and rather focus more on advocacy.
 - vi. Senator Ogunnowo: How would you include DEI in GR advocacy?
 - vii. Tiefentahler: I want to reach out to ISSS to make sure they have the resources available to vote. I also want to reach out to orgs like UNIDOS and DAC to promote their civic engagement as well as their service projects.
 - b. Senator Grace Kelley
 - Senator Kelley: I am a junior political science major from Cleveland, Ohio. I've been in Senate for two years. I've been involved in political activism since 2018, helping plan the March for Our Lives in Cleveland. I am also an Andrew Goodman Foundation ambassador, advocating for civic engagement on Miami's campus. I want to work with the office of Admissions and Orientation/Transitions to include Freedom Summer information in tours and other programs. I want to work with the Safety committee with Title IX as well as

other committees. I also want to work with other student organizations to give more knowledge as to what ASG is doing. I want a better relationship with the Student Trustees. I'd like to incorporate Miami into the Ohio Student Government Association. I'd like to work with DAC to provide resources to historically underrepresented groups.

- iii. Senator Kelley: I'd like to include civic engagement into international students orientation.
- iv. Senator Hughes: A lot of work in ASG recently has related to decisions made in the Ohio state legislature. How will you approach this?
- v. Senator Kelley: I'd like to increase the amount of communication between communities. Part of the OSGA is about acting as an advocacy body, and I would like to include Miami in this.

- ix. Senator Kelley: There is still some confusion as to what the student trustees do. Increased communication and a standing invitation to committee meetings will be important.

- a. SB212220: A Bill to Update the Bylaws of the Secretary for Off-Campus Affairs
 - i. Parliamentarian Elgazawi: Written in conjunction with the current Secretary. First thing, 101C 2 and 3 off campus senate districts. They are things that used to exist a while ago. There is no reason why they existed. They were portioned at random and people who held the position didn't actually live in those places. They are pointless so we took them out. 403 A I will yield to Sec. Manly.
 - ii. Sec Mannly: City commission and city council of Oxford sets the rules which are changing. There are 5 resident voting members and

5 students. Changing it to 4 and 1 year terms. Easier for students to plan out the changes by semester over 1 year. 1 2-year term will be an international student. This was a loose rule but with a cut of a seat and not being able to fit the seat those changes will happen. Liaison role did not exist in the last 2 years so we are reflecting it in the bylaws.

- iii. Sen. Hughes: There are 2 things at the bottom that say 403 A and when we talk about it until further context so is that supposed to be it
- iv. Parl: This is the mean body and this is the ellipses here of the continuation. Didn't feel like it was necessary to put it twice. This is contingent upon approval of the city of Oxford. This change here is happening regardless
- v. Student Body President Elect Kar: The student organization of commuter organization does not exist so this would help.
- vi. Sen Park Alternate: Love bylaw updates so we should pass it
- vii. Sen. Grabbow: If you're worried about the districts, I have no idea what those districts mean so that is not a huge deal.
- viii. Sen. Davies: I echo Sen. Grabbow, I appreciate the split of the 403 A. I think this bill is good.

- b. SB212221: A Bill to Update the Bylaws of the Secretary of Diversity & Inclusion
 - i. Parl: Fun fact the Secretary of DEI is not actually called this so we are reflecting that name change mostly in this bylaw update. The other things I would like to yield to Sec. Stephens.
 - ii. Sec. Stephens: The change in Section 206 Å where the secretarial duties are to heighten cultural awareness. I think the wording racial integration is very outdated and I think community integration would be better. I think the intent was to bring people that are different together. Changing the Climate Survey to be a bi-yearly climate survey. Currently it is at the end of one year and I don't think that this is efficient. I think the time to get the climate survey done. Anything sent to oversight is not based on this. I would like to put in a tracker or something in place in case of bias or disputes that make people feel uncomfortable in this place. A full scale climate survey I am concerned about the effectiveness of it. I hope that clarifies that change. Name changes and other senators have an opportunity to sit on committees so it isn't just the Sec.

- iii. Parl: I have nothing else to add.
- iv. Sen. Payne: Relating to climate survey if it's every 2 years, are we keeping people long enough to be effective rather than doing it yearly.
- v. Sec. Stephens: Across all committees we need to strengthen our approach to weighing in on senate culture. I don't think the climate survey is the effective way of doing this. Secretaries leading their committees is one way. Exploring more voices on the committee is another way.
- vi. Sec. of Safety and Wellness elect Parker alternate: I've never heard it called Secretary of Diversity and Inclusion so this is a wonderful piece of legislation.
- vii. Sen. Davies: I think that having a survey every semester might be more worthwhile and having a bigger conversation about the senate environment needs to happen. I don't think the nitty gritty wording used here should discourage voting for this legislation.
- viii. Sen. Hughes: I had a meeting with Dasha Wood and one of her main requests for ASG is continuous communication with the DEI so I looked at a way to do this. There were general expectations like putting on the Inclusion Forum yearly so I like that this is solidified now.

- d. Secretary of the Treasury election
 - i. Patrick Desch: Good evening, before we begin I would like to acknowledge the current Secretary of the Treasury. I have had the pleasure to work with both of the other candidates. I am a second year accounting student and second year in F&A. My coursework has prepared me for this. Sec. Waugh has been the pillar of F&A dealing with organizations I want to work with them closely. I would like to get the committee up to speed. I'd like to increase transparency and outreach so that orgs can get funded without controversy. I hope that you will consider me during voting.

- 2. Patrick Desch: I think that my background in accounting would do well with treasury.
- 3. Sen. Davies: When we are in the office, Sec. of Treasury is more ASG facing so how can we get senators more involved in how F&A works?
- 4. Patrick Desch: Direct those individuals to come back when there is someone in F&A in there or the email.
- 5. Sec. Morris: Since Treasury is internally focused, can you touch on what you plan to do?
- 6. Patrick Desch: Work with other secretaries to get their finances in order. Also, to support them and make sure they get what they need.
- 7. Sen. Hughes: How specifically do you plan to increase outreach?
- 8. Patrick Desch: Reviewing them and making sure they are documented in the best way possible.

- ii. Senator Maria DeVictor: Here are a few things about me. i'm going to talk more about what I'd like to do. Most of my initiatives are based on internal operating budget. Runs the main budget with ASG. I want to work with senate to fund initiatives. People don't know enough about the IOB to ask the right guestions about it. I think implementing the workshop at senate retreat would be great. We are all here to make change. When I looked more deeply into this position, I saw that we can use more about the budget to create tangible change on campus. I want to make this happen. Possibly include mentorship and help facilitate new ideas and work with funding to make them happen. We don't want to approve the IOB 60 times a year so I want to help facilitate how-tos so the semester is very planned out. Funding doesn't get the best reputation. I'd like to track people's complaints since there may be emails sent to anyone on the committee. Tracking them with a concerns form we can see how we can improve. An easier way to access voicing their concerns will help us get more feedback so that we can expand the F&A question forms.
 - Sec. Morris: Anything you'd like to add? Sen. Devictor: Sen. Hughes when she talked about Sec. DEI she reached out to multicultural organizations and I'd really like to work with those organizations as well. This position also works with other secretaries a lot. I want to work with other people well.
 - 2. Sen. Parker Alternate: Assuming Michael is not no confidence, how will you compliment him?
 - 3. Sen. Devictor: i've had the least amount of experience which means I have a lot of flexibility to help co-chair rather than splitting the two positions clearly.
 - 4. Sen. Davies: What is something that you'd do differently than Sec. Morris?
 - 5. Sen. Devictor: Coming from senate I have an advantage to how it works so that I can work with senators better. Helping with the initiatives and knowing what the different committees do is important.
 - 6. Sen. Grabbow: Why treasury over finance?
 - 7. Sen. Devictor: I think my work within senate leans more to treasury. I have the least amount of F&A experience where Finance is harder to adapt to than treasury.

- iii. Senator Megan Sparks: I have spent 2 years on F&A and I am the treasurer of Phi Mu. I served as a treasurer for 4 years in high school. 3 pillars to focus are clarity kindness, and org education. want to make myself available so we can fund internal events and outreach. Each district has outreach events and I want people to know what ASG is. I want them to know the org outside of funding. Internally, I have experience with Phi Mu's budget and to make myself approachable so that I can speak on how I can fund their initiatives. I want to sit at the beginning of senate so I can think about how to fund them. I have a wide experience of legislative experience. I reached out to 25 different treasures and presidents and ask what the problem is with F&A. I found the transition between org transitions and treasures so treasures don't know what to do. Evan Gates recommended making a common mishaps of where you can get funding for something like food that we cannot do. Posting when the deadlines to submit applications for. Have a funding feedback form after every funding hearing. Coordinate with comms.

 - 2. Sen. Sparks: I love F&A, I always talk to treasures about asking F&A for money. I want to make the experience for those people the best it can be.

 - 4. Sen. Sparks: I talked about external aspects since there were so many places I'd like to improve with the person in finance based on my experience. I wanted to do treasury since last year and I didn't think I was ready. Treasurer faces orgs just as much as finance in hearings.

- f. Secretary for Academic Affairs
 - i. Senator Cathleen McLaughlin: I appreciate you guys staying here so late. I'm a junior political science and journalism major. I am an off-campus senator involved in oversight, academic affairs. So far I've been on academic affairs for the last 3 semesters. Overseeing the outstanding professor awards, which I was allowed to spearhead for this year. This helped the process lessen bias that has been seen in the past. This semester Sec. Pal has allowed me to shadow her work. I think that these experiences have given me the confidence to be the best leader in this position. I am focusing on collaboration and outreach.
