### VII. Report A: Nighthawks Update, Senator Ryan Parker

- a. Senator Parker: This is Jade Cessna, intern for the Dean of Students.
- b. Jade Cessna: I have been working on this since my freshman year. Nighthawks will be a student organization that will help students get home safely. We have had a great amount of support from our community. I will be moving on from this project after this year, and we decided to make this program a student organization after consulting with the school.
- c. Senator Parker: In April, we have been trying to build an executive board. May will see interviews for the board. In September, we hope to get funding from ASG and search for general members. We are hoping to launch the program in October, and we will evaluate how it went in November. ASG involvement will see periodic updates, cabinet and ASG leadership involvement, and open lines of communication.
- d. Senator Hughes: What is the plan to maintain a perception of Nighthawks as something people can be secure in?

- e. Jade Cessna: No one actually knew we tried to be departmentally affiliated. We wanted to see what they can provide to us from another perspective other than being departmentally affected. I don't think students will be concerned about the distinction.
- f. Senator Madrigal: What is needed to make the hypotheticals concrete?
- g. Jade Cessna: This project went on the backburner during COVID. We really need to set up a great executive board.
- h. Senator Stein: For the general body, will you be holding interviews?
- i. Jade Cessna: There will definitely be interviews for students that want to be Nighthawks. Background checks will be necessary, and we have to find a way to pay for it.
- j. Senator Parker: Until those questions can be answered, we will not be launching the program.
- k. Senator Stack: Can you expand on the steps you are using to build the executive board?
- I. Jade Cessna: I've started connecting with other students including Ryan and we have created a strong network with the Dean of Students. She has recommended students for several positions.
- m. Senator DeVictor: Will the funding be going to DAB and then Nighthawks?
- n. Jade Cessna: We are separating from DAB, and we'll have to rework some of the legislation on some of that.
- o. VP McKeon: If you are planning on being a new student org, what are some of the startup costs and will you be able to fund them?
- p. Jade Cessna: We need to figure that out. We were going to be Tier 1 at the beginning, and our startup cost will most likely be about \$30,000.
- q. Senator Giaquinto: What role will MUPD play in this?
- r. Jade Cessna: MUPD will be training the Nighthawks and serving as a point of contact?
- s. Senator Kelley: What steps are you envisioning taking to protect Nighthawks?
- t. Jade Cessna: Through training and through making sure they know which situations to step out of.
- u. Senator Hughes: Are you extending the non-bias training past MUPD?
- v. Jade Cessna: That's a great idea, and it is definitely something we will be bringing to the table.

# VIII. Report B: Off-Campus Affairs Updates, Secretary Connor Manley

a. Secretary Manley: Tonight I want to talk about what Off-Campus does. As secretary, I try to communicate, lead, and be versatile. Lots of communication is involved in this and it also provides several leadership positions, including SCRC. Personal safety alarms was our big initiative started by Senator Webb this semester. We had lots of outreach and distribution went extremely well. We also have worked on renters' rights, which are now located in residence halls. We have started working on an

Off Campus Orientation packet for newly off-campus students. We are working on speaking with international students to better understand their issues as well. We are working on recycling, snow routes, and Sharefest as well. With SCRC, we want to inspect sidewalks in the city, advocate for an AmTrak station, and rewrite the ordinance for SCRC to ensure equal representation for students. In the future, we will be bolstering the personal alarm initiative, doing more with renters' rights, and doing a walk audit in the city of Oxford.

- b. Senator Parker: Is it possible to get an email list of off-campus students?
- c. Secretary Manley: We might be able to, but I can't get access to it for legal reasons.
- d. Senator Stein: Have you considered expanding to Greyhound bus stops as well?
- e. Secretary Manley: AmTrak initiated that conversation, but I think it is a really good idea.
- f. Senator Hughes: What do you think the accessibility audits will look like as well as the follow through?
- g. Secretary Manley: We will be walking through and communicating with the City of Oxford.
- h. Senator Ogunnowo: Does the school keep track of students that move off-campus?
- i. Secretary Manley: I am not sure.
- j. Senator Prebles: We want to try and figure it out, but next year we can look into something like that.
- k. Senator Gay: What has the work looked this year for AmTrak and what will it look like?
- I. Secretary Manley: There is a bus depot being constructed at Chestnut Field. AmTrak is up next to be built, and should be coming in a few years.
- m. Senator Davies: How can students not in ASG get involved with the City of Oxford and SCRC?
- n. Secretary Manley: Every meeting is a public meeting. So come hang out with us!
- IX. Report C: Academic Affairs Updates, Secretary Ruku Pal
  - Secretary Pal: I sit on a lot of committees in my role as secretary. All undergraduate advisors have representation in the Undergraduate Academic Advising Council. The Council of Undergraduate Curriculum handles all things related, and the Academic Policy committee reviews academic policies. Through University Senate, I work with Dr. Amy Bergerson and the provost's office. Over the past couple of years, we have worked on many things, especially during COVID. We extended credit/no-credit as well as reviewing our relationship with the remote proctoring service Proctorio. We have worked on various resources and accessibility concerns, revisions to the university attendance policy, as

well as running the Outstanding Professor Awards. We updated the Statement of Good Teaching Practices, addressed student concerns and issues, and worked on a search committee for the Dean of Undergraduate Education.

  - a. Senator Parker: This legislation is looking to extend the Unity Funding cap extension passed last semester.

  - a. Senator Ryan Parker

    - iv. Secretary Sutton: Why do you want to run for safety?
    - v. Senator Parker: When I ran for senate, the main goal I had in mind were issues surrounding safety. That is very important to me and I feel I do have very passionate and different ideas.
    - vi. Secretary Stephens: How do you plan to eliminate barriers for students surrounding counseling services and title IX?
    - vii. Senator Parker: Including multicultural orgs in that process brings a unique perspective. I do not have that underrepresented community. Surveying students is really valuable.
    - viii. Senator Hughes: Could you go into more details about the reforms you want in student life and how that will affect RAs?
    - ix. Senator Parker: I will collaborate with the future on campus secretary and the RA senator to differentiate what an RA is and how do you differentiate having a friend as an RA. We want to increase mental health for RAs.
