VII. Report A: Student Dining Hall Committee Updates, *Secretary Becca Pallant*

- a. Secretary Pallant: The dining hall committee serves to present issues with dining to Miami administrators. The first concern I want to present is the staff shortage Miami is facing. We are averaging 8-10 swipes per minute at dining halls. There are usually wait times with full staff. We are pushing for students to try and go during off times, and for students to not go to the same places.
- b. Secretary Agee: Another issue is with the containers used at Dining Halls. Students are swiping in and taking lots of food, and the school is going through more food as a result. We are using the amount of food to serve 1200 students for only about 800 students.

E. CoS Wu: more about your background and research on advocacy?

1. Worked in college administration and got masters in NYC



2. Began to realize the answers she was getting while protesting for more diversity in her own program were the same answers she was encouraged to give as an administrator
3. Felt university was focusing on appeasement instead of actual systemic change
4. Asking “Why are students not ready for college” vs “why aren’t colleges ready for students”
5. Dissertation on University of Virginia & UNC Chapel Hill¹
6. When asked “how can we change our institution” it is better to look at your own institution and see when was a time when Miami made a positive change that was helpful and analyze those power structures and dynamics
7. Before she was hired at Miami she was asked to join the DEI taskforce. The Objective of a taskforce was to create immediate change.
8. Work with Undergrads and grad students to do focus groups.
9. Sec. Stephens: in your discussions what can improve the gap between faculty and students in terms of communication
 - a) Dr. Cho: Part of the disadvantage is that students graduate within 4 to 6 years. There is a difference in temporal context because faculty are often here for decades and students are only here for 4-6 years. Analyzing how the black world studies was all merged into global studies. Looking at academic socialization and how students and faculty navigate a university. Miami is supposed to be a 40/40/20 breakdown for faculty (40% research, 40% teaching, 20% service) faculty are not necessarily incentivized to to improve the student experience. If students leave a very negative course eval that will not necessarily go anywhere because it will be filtered out before it reaches the chair. Course evals are more about if faculty should be promoted not if the student experience is positive. There is a gap in the information regarding how university admin works to the students

10. Sec. Stephens: the center of the office of Diversity and Inclusion has a very high turnover rate. There is going to be a disconnect between the direction/vision for the university if the position in DEI offices are constantly changing.
 - a) Dr. Cho: COACHE is currently analyzing the cost to an institution if the faculty keeps leaving. Some of the justifications that she has seen towards senior level administrators is that people leaving student affairs is very normalized. The questions should be “why are people leaving and why is it generally a certain type of faculty members”. Institutions are often unwilling to conduct exit interviews. People assume that this is normal because entry level professionals are often moving. At Miami the BOT can encourage certain vendors to come to the area. Asking the question of “who is the administration”. We often have many more “levers of change” that can help adjust the geo political context of where a university is. Can be as simple as asking where dorms are going to be and what kind of food is going to be served at the university.
 - b) Scott Walter: people in student affairs across the country are feeling burned out due to COVID
 - c) Dr. Cho: In our rush to normalize a post COVID world we are missing the impact on our faculty and it is not surprising that people are leaving the field of student affairs.
11. VP McKeon: in your experience and research looking at other institutions have you seen any examples of how student gov/leadership fits into a university ecosystem. Can you help us conceptualize how our role fits into Miami
 - a) Dr. Cho: I am interest in the early constructions of the University and seeing how students fit into it. Are you guys allowed to sit in on BOT meetings?
 - (1) SBP Jett: We are allowed to present at the board briefly and we have two student trustees on the board
 - b) Dr. Cho: A lot of time increased student involvement occurs after a big protest. When I was at the City College of New York students engaged in both peaceful and nonpeaceful protests. I am passionate



about getting students paid and this allows for a certain degree of permanence in these student positions. At UCLA they just started a DEI taskforce and the students on the task force are getting stipends

- c) COS Wu:
 - d) Dr. Cho: This is a form of appeasement. There are people who are obviously on your side in the room even if they cannot show it publically. Find these people and figure out how your voices are advocating for you on the side and behind closed doors. Work with a strategy of divide and conquer and find out who is on your side and who you can utilize. It is helpful to articulate to these groups who you students are accountable to so they know how/what you will be reporting. This puts pressure on administrators because it allows you to act as reporters to the larger student body. You are not just reporting to students but you are also reporting to alumni. University rankings are based on the percentage of alumni contribution. Strengthening relationships with alumni can allow you to leverage this.
 - e) Scott Walter : you must be honest about your history as an institution and what has and hasn't worked and what an institution has neglected in the past.
 - f) Dr. Cho: go to [IPEDS](#) to look up data regarding various institutions. This is a potential resource.
12. Sec. Manley: the city of oxford is looking to see how Oxford is somewhere people work and live
- a) Dr. Cho: There have been several mayors of Oxford who graduated from Miami. Many of the EHS faculty are on school boards in Oxford. Looking at "narratives of conversations". For example why do students leave, could it be something as simple as they don't find the food they want? Feel free to reach out to me for more information regarding research on these topics.
 - b) Dr. Cho: I created the institutional response framework to assess how students' demands get responded to: schisming, vs appeasement, vs cooperation, vs partnership.
